MONTHLY FLAT RATE FREQUENTLY ASKED QUESTIONS

PLEASE HELP ME UNDERSTAND THE MONTHLY BILLING FORMAT.

Due to the approved AUSD schedule there are only 10 days of possible care in August & 6 days in June, therefore we are adopting a 9 period flat monthly billing rate rather than having different rates every month.

THERE ARE ONLY 15 POSSIBLE DAYS OF CARE IN DECEMBER. WILL I BE PAYING THE SAME AMOUNT?

Yes, you are paying the same amount each month whether it's for only 15 days in November, for 30 days for August & September or 25 days for May & June. We have averaged it out to be 20 days per period (180 possible days of care / 9 Periods = 20 days per Period or 13 days for 3-day Care).

WHEN ARE THE FEES DUE?

On the first day of every month, except for Period 1. Fees for Period 1 are due before on the first day of school which is August 19, 2019 (next Period 2 fees are due on Oct. 1, 2019. The last payment is due on May 1st. You will not receive a stmt. on June).
