If you have enrolled with AutoPay, your payment(s) will be processed on the First Day of Care.

- Late Fees**
1. Payments received 2 days after the first day of care will be charged a **Late Payment Fee of \$35.00** per child.
 2. To avoid being charged a Late Payment Fee, payments must be received via USPS only to 1724 Santa Clara Ave., Alameda, Ca 94501 by 6:00 p.m., the day after the first day of care each period. Please refer to the Rate Schedule and Calendar of Due Dates.
 3. Childcare will be denied if all payments are not paid within 3 days after the first day of care (on the 4th day). After care is denied, the Enrolling Parent has 5 business days to pay all fees or the child will be dropped from the program. After being dropped, the child can be re-enrolled (\$65) if space is available during the same school year.
 4. Payments mailed by USPS and applicable based on the DATE the payment is RECEIVED at the main office and not by the postmark date on the envelope.
 5. Rates are calculated based 180 day of school year. For more information on days of care, please see the Care Calendar.
